TO REGISTER complete the following:

STEP 1: Fill out the Individual Information Card & Application - Include your name, address, email, phone number(s), school and grade.

STEP 2: Pogo Field Hockey Agreement and Release of Liability – Each player, must fill out the Pogo Agreement and Release of Liability waiver with a signature, printed name and date signed.

STEP 3: Pay the Individual Fee - Personal checks, certified checks, cash, or money order will be accepted for payment of league fees. Checks should be made payable to "**RUSH Field Hockey**".

STEP 4: Escondido Sports Center I.D. Cards - All players on the roster must have a current Sports Center I.D. card before they participate. I.D. cards can be purchased for **\$19** from the Escondido Sports Center during normal business hours: M-F 3pm – 7pm, Sat. 8am – 6pm Sun. 1- 6pm. Player I.D. cards must be presented to POGO official before participation. Those players unable to present a valid Sports Center I.D. card will not be permitted to participate. I.D. cards are valid for (1) one year!

POGO FIELD HOCKEY AGREEMENT AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in POGO Field Hockey, and related events and activities, the undersigned:

1. Acknowledge and fully understand that each participant will be engaging in hazardous recreational activities that involve risk or serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence but action, inaction or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.
2. Assume all the foregoing risk and accept personal responsibility for the damages following such injury, permanent disability or death.
3. I agree to indemnify, waive, discharge and covenant not to sue POGO Field Hockey, RUSH Field Hockey and/or their representative, administrators, directors, officials, coaches, volunteers, sponsors, officers, and, if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releases," from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of releases otherwise.

I agree to hold harmless and release POGO Field Hockey, its representative, administrators, directors, officials, coaches, volunteers, sponsors, officers, and, if applicable, owners and leasers of premises used to conduct the event, from any and all lawsuits, damages, claims, judgments, loss, liability, or expenses arising out of participating in any activity relating to POGO Field Hockey.
